

## **FAMILIARIZATION PROGRAMME FOR INDEPENDENT DIRECTORS**

Familiarization of Independent Directors is an ongoing process in Chambal Fertilisers and Chemicals Limited ("Company"). The Independent Directors are given updates on the Company, its operations, business model, business risks, the industry in which it operates etc.

Details of familiarization programme in the Company, are as under:

- 1) When a new Independent Director joins the Board, he/she is provided with an 'information kit' which is a compilation of relevant information about the Company, its business, financial performance, Code of Conduct & Ethics and other policies, subsidiaries, JVs etc.
- 2) The Company conducts session(s) for Independent Directors, with the help of in-house team or by engaging external experts (wherever required), to familiarize them on various aspects of the business of the Company, and other relevant topics such as roles, responsibilities, duties & rights of directors, etc.
- 3) Presentation(s) on relevant and important changes in the regulatory framework (including those related to their rights, duties, roles and responsibilities) are put up to the Board members from time to time.
- 4) Detailed update on the business and operations of the Company, subsidiaries & JV, important developments in the industry, business risks, etc. is given to the Directors on quarterly basis, and presentations are also made in this regard in meetings of the Board/Audit Committee.
- 5) Independent Directors also visit the plant.
