Strong growth continues in CPC &SN

- 41% growth in contribution y-o-y

- Normal Monsoon forecast by multiple agencies augurs well for the Kharif season















Urea Production and Sales (In Lakh MT)




Revenue from Operations (Rs in Crore)





P & K Fertilisers Sales (In Lakh MT)




- Urea: Higher sales volume resulted in higher revenue, partly adjusted with lower gas cost

- CPC & SN: Increase in revenue due to higher volumes and better realization


Financial Position – Standalone (Rs in Crore)




