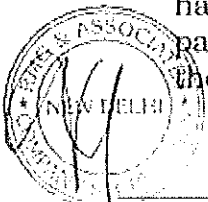
The Board of Directors of the Company at its meeting held on March 14, 2016 has appointed me as Scrutinizer to conduct the Postal Ballot process in respect of the Special Resolution proposed in the Postal Ballot Notice dated March 14, 2016 (hereinafter referred to as "**Postal Ballot Notice**"), as described below:

Type and description of the Special Resolution

Special Resolution to approve the sale, assignment, transfer and delivery by ISGN Corporation, a material subsidiary of the Company, of its entire shareholding in ISGN Solutions, Inc. (a subsidiary of ISGN Corporation and downstream subsidiary of the Company) to Firstsource Group USA, Inc.

I hereby submit my report on the voting on the Special Resolution proposed in the Postal Ballot Notice, as under:

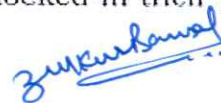
1. In terms of Section 108 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), the Company has made arrangement with National Securities Depository Limited ("NSDL") for providing facility of voting through electronic means ("e-voting") to its members. The members of the Company had option to cast their vote either through e-voting or by physical postal ballot form.
2. The Company has completed dispatch of Postal Ballot Notice along with postal ballot form and postage prepaid self-addressed business reply envelope (in case of documents sent in physical form) on April 02, 2016. The aforesaid documents have been mailed electronically to those members who have registered their email addresses with the Company or their depository participant and in physical form to the members who have not registered their email addresses as specified above.



3. The Company has published an advertisement on April 03, 2016, about the dispatch of Postal Ballot Notice in The Financial Express (English Newspaper – All Editions), The Times of India (English Newspaper – Jaipur Edition) and Dainik Navjyoti (Hindi Newspaper - Kota Edition).
4. The members of the Company whose names were recorded in the Register of Members or in the register of beneficial owners maintained by the depositories as on March 25, 2016 were entitled to vote on the Special Resolution as set out in the Postal Ballot Notice.
5. The votes exercised through e-voting from April 04, 2016 (0900 Hours) to May 03, 2016 (1700 Hours) and all physical postal ballot forms received till May 03, 2016 (1700 Hours), being the last date for e-voting and receipt of postal ballot forms, were considered for my scrutiny.
6. The votes cast through e-voting were unblocked on May 03, 2016 in the presence of two witnesses, Mr. Manish Kumar R/o 170-B, Pocket – 1, Mayur Vihar, Phase – I, New Delhi - 110091 and Mr. Ankur Bansal R/o M/s Laxmi Narayan Ashok Kumar, 33-A, Old Anaj Mandi, Sonapat, Haryana – 131001, who are not in employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.

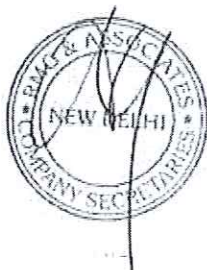

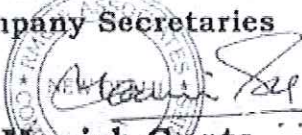
